

2. France - Notice to Manufacturers, Importers and Distributors of Cot Bumpers. (Dec.2, 2014)

1. Cot bumpers shall satisfy the general safety obligation enacted by the Article L221-1 of Consumer Code: "Products and services must, under normal conditions of use or under other circumstances that may reasonably be foreseen by the professional, offer the safety that can legitimately be expected and must not be a danger to public health."

2. These products shall be designed and manufactured so as to protect children from the risk of strangulation linked to the presence of ribbons, cords and straps on cot bumpers, freely or in loops, intended to form loops or nooses ("nœuds coulants" in French) or likely to form them under reasonably foreseeable conditions. Points 4.4.1.2 and 4.4.2 of the standard XP G 30-106 of April 2012 can be referred to for this risk.

These products shall accompany the useful information that allows the consumer to evaluate the risks inherent in a product during its duration of normal or reasonably foreseeable use and to take precautions when these risks are not immediately obvious without adequate warnings. 当这些风险不是很明显并且没有足够的警示时,该产品应该提供有用的信息,用于帮助消费者去评估在正常或可预见的合理使用情况下的产品内在风险以及采取预防措施。

The Minister of Health of the Republic of Lithuania has proposed the Draft Lithuanian Hygiene Standard HN 41:2014 "School-Related Goods: General Health & Safety Requirements". 立陶宛公共安全部长提议了立陶宛卫生标准草案 HN41: 2014"学校用品: 通用健康及安全要求"。

The Minister of Health of the Republic of Lithuania has proposed the Draft Lithuanian Hygiene Standard HN 41:2014 "School-Related Goods: General Health & Safety Requirements". If approved, it will replace HN 41:2003 "School-Related Goods" as amended. Here are highlights of the new draft standard: Scope

This new draft standard applies to school-related goods including school backpacks and school stationery. School stationery do not include the articles defined as toys in the Order regarding Approval of the Technical Regulation for the Safety of Toys, for example, drawing paints, finger brushing paints, drawing varnishes, modeling materials intended for children seducation

Vietnam has published Government Decree No.100/2014/ND-CP on trading and use of nutritional products for infants, feeding bottles and teats in order to promote breastfeeding. This decree will take effect from 1 March 2015

For domestically produced or imported feeding bottles and teats, there are labelling requirements and here are the highlights:

A draft Commission Delegated Directive has been published recently to propose the addition of 4 phthalates to the list of restricted substances in Annex II to Directive 2011/65/EU (RoHS 2) 一草案指令最近已经公布,提议在2011/65/EU (RoHS 2)附录2中的限用物质列表内新增4种邻苯二甲酸酯。

A draft Commission Delegated Directive has been published recently to propose the addition of 4 phthalates to the list of restricted substances in Annex II to Directive 2011/65/EU (RoHS 2). If approved as proposed, European Union member states shall apply these provisions from 22 July 2019. Here are highlights of the draft Delegated Directive:

- 2. The restriction of DEHP, BBP, DBP and DIBP shall apply to medical devices as well as monitoring and control instruments from 22 July 2021 instead.

3. The restriction of DEHP, BBP and DBP shall not apply to toys which are already subject to the restriction of DEHP, BBP and DBP through entry 51 of Annex XVII to Regulation (EC) No 1907/2006 (REACH).

13、EU-Public Consultation on Proposed Restriction of PFOA, PFOA Salts & PFOA -related Substances (Dec.19, 2014)

On 17 December 2014, the European Chemicals Agency (ECHA) has launched a public consultation on a proposed restriction of perfluorooctanoic acid (PFOA), PFOA salts and PFOA-related substances (substances that may degrade to PFOA).

2014年12月17日,欧洲化学品管理局发布了公开咨询有关于限用全氟辛酸,含全氟辛酸盐类和全氟辛酸有关物质的提案。该公开咨询将持续6个月直至2015年6月17日,2015年3月1日前的早期建议可用于首次讨论。

The proposed restriction is expected to eliminate most of emissions and related exposures of PFOA to both humans and the environment stemming from manufacturing and use of PFOA and PFOA-related substances and articles in the European Union (EU).

14. China – Draft GB Standard 6675.11 on Safety of Toys – Part 11: Swings, slides and similar activity toys for indoor and outdoor family domestic use (Approved). (Dec.24,2014)

鉴于来自全球恐怖行动和海盗行为日益升级的威胁,各国政府和海关组织实施了供应链安全标准,以确保贸易往来的安全,使之免受恐怖主义行为的危害,打击非法的贩运。在执行和遵守新的国际供应链安全标准的过程中,企业必须评估他们的供应链,以识别、减轻和消除所有潜在的安全风险。GSV(Global Security Verification - 全球供应链安全验证)体系的使命是与全球的供应商和进口商合作促进全球安全认证体系的开发,帮助所有成员加强安全保障和风险控制、提升供应链效率,并降低成本。GSV的先进评分体系已得到全球认可,适用于各类国际进口安全体系的要求,包括C-TPAT、AEO、PIP和WCO,其评估结果可为多家进口商共用,为厂家节省时间和成本,已为绝大多数大型进口商所接受。



3、验货流程及技术基础培训:

验货服务,在进出口贸易中也称为公证验货或者出口检验,是按委托方或者买家的要求,代表委托方或买家对供货质量及定货、购销合同中的其它相关内容进行检查验收的一项活动,目的是查验供货方所供货物是否满足定货合同的要求和买方的其他特殊要求。本课程会对基本验货流程和验货技术进行讲授,并会配合实际操作的模拟指导,达到提高学员技术基础和实践能力的目的。Intertek 在质量控制领域有超过100年的历史,出具的验货报告得到了全球买家的认可。
